

- Two-story floor plan, ground floor with total covers capacity of 326 (of which 161 inside, 165 outside), mezzanine level with dance/seating area and total capacity of 122 persons.
- Average check for food and drinks estimated, depending on the night, respectively, at US\$ 85-100, and 50-85. Compare with average check at Komodo of US\$ 93, Makoto and Prime 112 of US\$ 120.
- Average week sales projected at US\$ 347,900.
 Yearly at over US\$ 13 mln. Compare with Komodo at over 16 mln.
- > Yearly sales in 2020 projected at >13 mln, 2021 at >14,9 mln, 2020 at >16 mln.
